Dear Sir,

In rejoinder to your reply dated 03 April 2023, we have to state as follows:-

1. With reference to paragraph 1 of your reply, we have to apply a different yardstick for evaluating the affidavits filed by Mr. Ajit Rodrigues as the averments contained in them are factoids and not based on unimpeachable facts. The Salsette Society ensures that their affidavits are factually correct and supported by documentary proof.

2. With reference to paragraph 2 of your reply, we have to state that since the matter is subjudice the three nominated members of the Salsette Society who were present at the meeting held on 27<sup>th</sup> January 2023 thought it prudent to refrain from making any comment or raising any objection lest it would be construed as contempt of court. Even assuming that they did raise any objection, it would not have found a place in the minutes of the meeting. Sadly, this observation has been made by the three nominated members.

Most importantly, your Trustee, Roger Pereira has vitiated the entire atmosphere by his tirade at your Member's Nite on 25 January 2023 when the matter was subjudice.

3. With reference to paragraphs 3 and 4 of your reply, we dare say that the Gymkhana will continue to incur monetary loss if the Managing Committee acts without application of mind or to spite their members as is borne out of the hasty, spiteful and unwarranted suspension of two members. The wasteful expenditure was demonstrated in Suit No. L 199, Suit No. L 18274 & Suit No. L 18263 of 2021. To evade the claim made for substantial damages claimed by the aggrieved members and to avoid any adverse finding from the Court, the Gymkhana made post-haste to settle matters. Another glaring example is the fruitless inquiry initiated by the Gymkhana by expending exorbitant sums of money towards the fees of the inquiry officer who happens to be a retired Judge of the Bombay High Court. This wasteful expenditure is to spite a member and could not have been "in the interest of the


